- Receive shipping advice

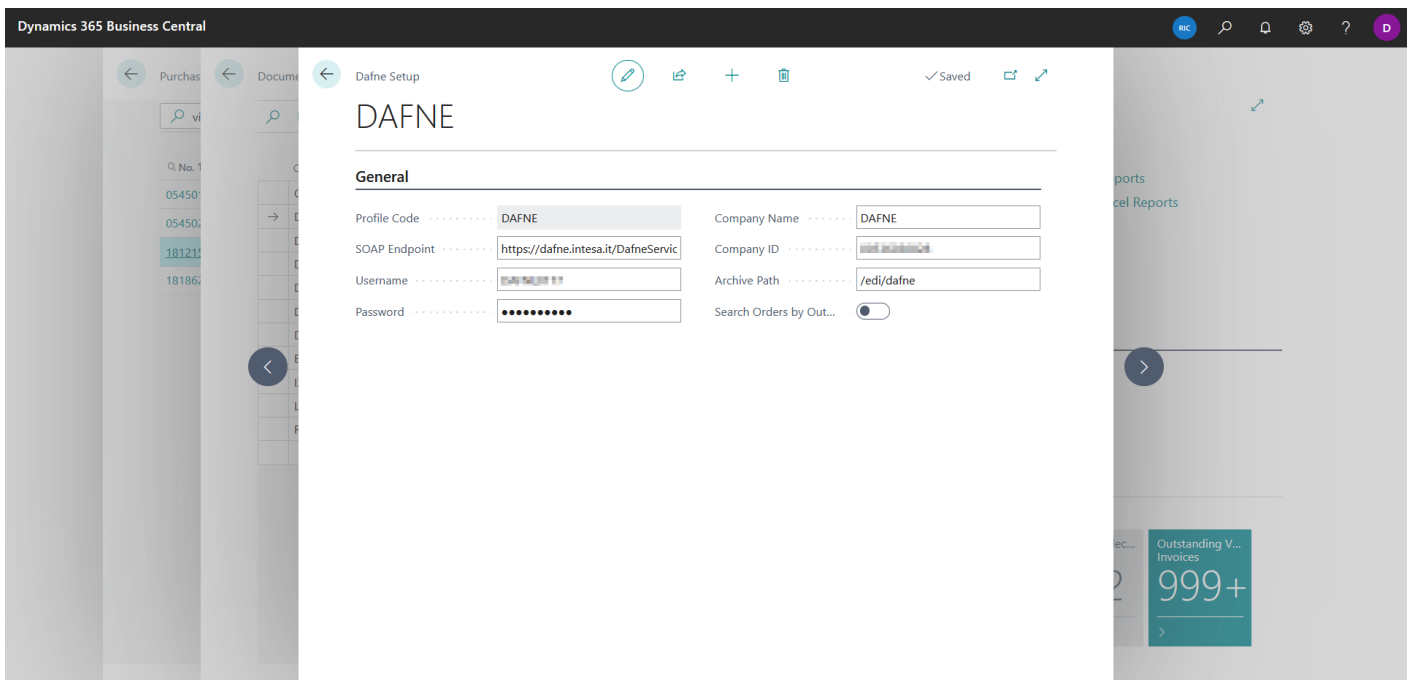
Purchases Source

For each "Purchases Source" (that groups several items of the same manufacturer) can be set the DAFNE® ID.

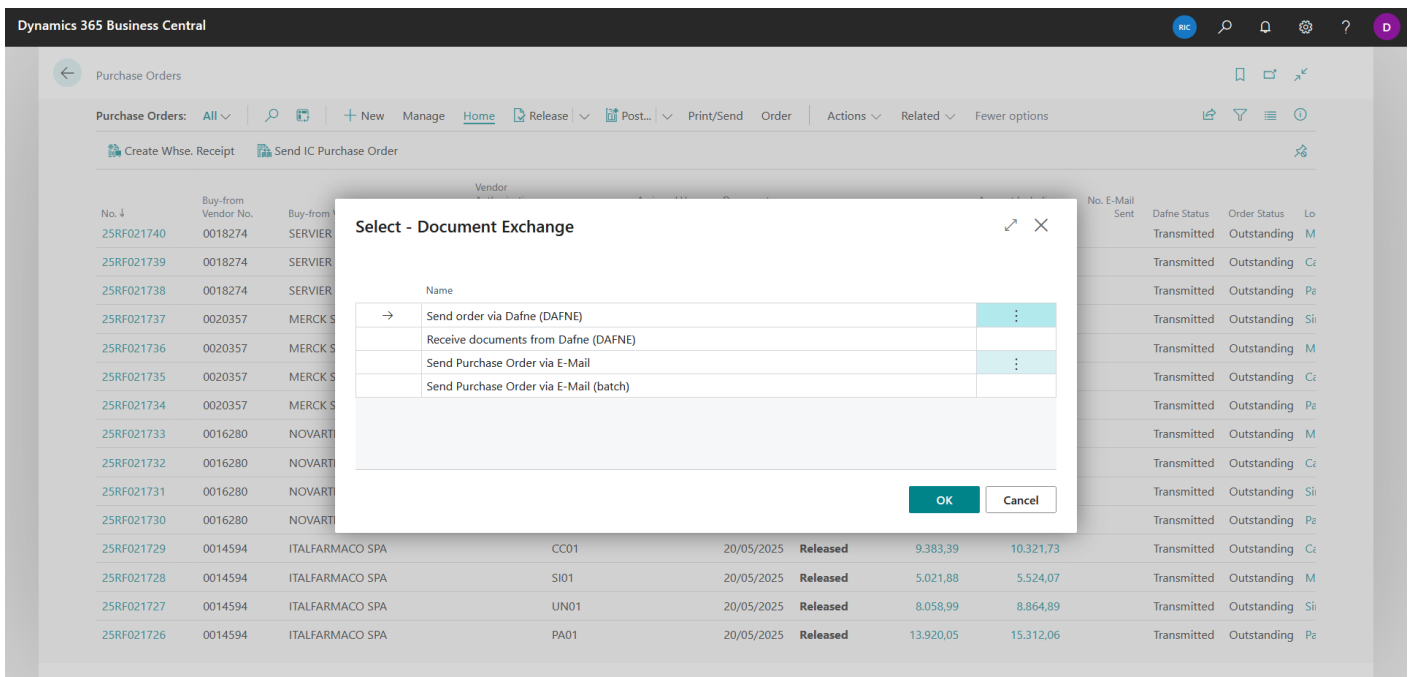
Exchange Profile
